Cllr Stuart opened the meeting at 7.30pm.

APOLOGIES

Cllr Bennett (CDC) had sent an apology for absence as he had a domestic function to attend. Emily Hallett had sent an apology as she was unwell.

AGENDA RESTRUCTURING

It was proposed by Cllr Stuart and seconded by Cllr Kimberley that the Councillor's Reports of Cllr S. Parsons (GCC) and Cllr. Ms. J. Layton (CDC) are promoted in the order to follow the R Way report. The Parish Council was all in favour.

MINUTES OF THE MEETING HELD ON 6TH NOVEMBER 2013

It was proposed by Cllr Nicholas and seconded by Cllr Kimberley that the minutes were a true and accurate record. Cllr Webb abstained as he had not attended the meeting. The remainder of the Parish Council was in favour.

R WAY REPORT

Cllr Chris Wearing gave the report explaining that the absence of Emily Hallett had made the running of the group more difficult but with the valuable help of Jasmin Tresadern and Jai Cunningham with her innovative ideas, the sessions were working well. The three organisers were gradually preparing the youngsters to make a financial contribution to the operation of the group by explaining that there were significant costs involved in the running of the project. Their explanations were generally understood and well received although some cost structure to allow for family membership must be considered. The number of participants was very good and increasing. Cllr Jay stated that the project would have collapsed without the input from Chris and Jasmin. Cllr Mrs Land enquired of them if they were enjoying the experience and both replied positively that they were.

REPORT FROM CLLR S. PARSONS (GCC)

Cllr Parsons reported on his perception of village affairs especially on flooding and drainage issues. Cllr Parsons informed the Parish Council that a scheme for consultation on creating a dual carriageway from Brimpsfield to the bottom of Birdlip Hill had been agreed. The cost was expected to be in the region of £230m. Cllr Parsons informed Parish Councillors that the

decision to refuse planning permission for the incinerator application by Gloucestershire County Council would now be determined by an inspector appointed by the Secretary of State. Cllr Jay was concerned that the S.106 contribution from the Mallards was in jeopardy as the bus service was being cut back. The proposed consultation had not, in his opinion, been carried out and it was now impossible to compare the use of the bus service before the development and now that residents had taken up occupancy in the Mallards. Cllr Parsons would investigate. Cllr Parsons wished the Parish Councillors a happy Christmas and a prosperous New Year.

REPORT FROM CLLR Ms J. LAYTON (CDC)

Cllr Ms Layton (CDC) gave her report on various topics but concentrated on Water Park issues. Cllr Nicholas was insistent that Cllr Ms Layton took the message back to the District Council that the proposed representation changes to the current division of the district were not welcome and asked her to find out, in his words “whose stupid idea was it to seek such change”. Parish Councillors did not disagree with his sentiments and generally the Parish Council was not in favour that the Parish should be divided or parts annexed to satisfy a numerical criteria.

MATTERS ARISING

There were no matters arising.

CLERK’S REPORT

Due to taking annual leave during November the weekly average hours work is distorted. Of the six available working days I averaged 7½ hours per day. I am more than content with the situation. Thank you all for the co-operation given during my leave.

REPORT ON THE MEETING OF THE PLAYING FIELDS AND VILLAGE MAINTENANCE COMMITTEE HELD ON MONDAY 9TH DECEMBER 2013

Cllr Mrs Chapman, Cllr Mrs Chubb, Cllr Harris, Cllr Kimberley, Cllr Mrs Land, Cllr Mrs Tunbridge, Cllr Nicholas and Cllr Stuart had attended the meeting. Cllr Stuart opened the meeting at 7pm.

Matters Arising from previous Minutes

Compost Scheme (Page 3187)

Cllr Stuart informed the Committee that the chipping exercise had been carried out.

Herbage alongside the wall of 24 The Limes (Page 3187)

Cllr Stuart informed the Committee that the majority of the work had been carried out satisfactorily. If necessary the contractor Andy Woodman, A.W. Services will return in the Spring to make sure that the grass has seeded.

Cerney Wick Play Area (Page 3187)

The Parish Council is grateful to James Harris Contracting for withdrawing from the contract for ground work at Cerney Wick Play Area. James Harris Contracting had been awarded the contract but due to other commitments had been unable to commence work to suit the timetable of PLAYahead Ltd, the equipment suppliers and installers. It was agreed with PLAYahead Ltd that it takes on the ground work for the same price as quoted by James Harris Contracting. There was confusion on whether permission to use a neighbouring paddock had been properly attained by PLAYahead Ltd. The wall separating the play area from the neighbouring property had been damaged to allow access for the removal of material and some further damage to the roadside ditch had occurred.

Pay Back in the Community (Page 3198)

Cllr Stuart had been in contact with Pay Back in the Community regarding the possibility of their redecorating the interior of the Village Hall and also doing the heavy turning of the compost at Upper Up. He will be meeting a representative of the team this coming Sunday morning.

INSPECTION REPORTS**Robert Franklin Way**

Cllr Mrs Chubb and Cllr Mrs Tunbridge had carried out the weekly inspections at Robert Franklin Way play area. Cllr Mrs Tunbridge had noted that the latch on the gate to the children's enclosed play area had not been repaired. Cllr Harris informed her that the necessary adjustment had been made very recently.

Cerney Wick

Cllr Mrs Chapman reported that the play area was out of commission awaiting refurbishment.

Upper Up

Cllr Stuart had carried out the inspections. The playing field was in good order.

RECOMMENDATION TO THE FINANCE COMMITTEE

The Committee had no recommendations for the Finance Committee.

UPPER UP CULVERT WORK

Cllr Stuart reported that work to uncover the culvert between the two holes on the corner of the road as it enters the village had started. A section of the old stone built culvert had been unearthed alongside the driveway going into the field. Cllr Stuart was of the opinion that Thames Water could not be blamed for the damage to the culvert as there was no visible evidence of any trenches having been dug across the line of the drain. It appeared that the culvert had collapsed probably under the weight of heavy vehicles using the entrance to the field. Lawrence King (CDC) had given his permission to install one 450mm pipe to clear the problem. A cctv survey from Rose Cottage in Upper Up to the culvert had not found any problem in this drain and the gulleys were clear of obstruction all the way. Cllr Stuart was concerned at the suggestion from Scott Macauley-Lowe (Gloucestershire Highways) that the Parish Council should fund 20% of the cost of the work. He based his argument on two counts: (a) no competitive quotations had been sought; (b) as the area is a publicly maintained highway it is the responsibility of Gloucestershire Highways. After considerable discussion on whether a contribution should be made the Committee recommended that the Parish Council should not to make any percentage contribution as this would create a precedent for all future "joint projects".

Cllr Stuart informed the Committee that he would be meeting with Jenny Phelps (FWAG) and a member of the Environment Agency at lunch time on 11th December to discuss future projects to alleviate potential flooding problems. Cllr Stuart thanked Cllr Harris for his valuable input at the meeting he attended, referred to above, which he considered a worthwhile exercise.

CLOSURE OF CERNEY WICK PLAY AREA

PLAYahead Ltd has recommended that the play area is closed for public use until the safety matting has been installed and to allow the soil to settle and reseeding to take place. The Committee was in full agreement and recommends that the Parish Council accepts this

proposal. At the Parish Council meeting it was proposed by Cllr Stuart and seconded by Cllr Mrs Chapman that the Parish Council accepts the advice of the equipment installer and closes the play area until the equipment is installed. The Parish Council was in full agreement.

COUNCILLORS' REPORTS

A resident had enquired from Cllr Nicholas why the highway from Bow Wow to Upper Sisters farm had been resurfaced whilst other parts of the highway through the village had been neglected. Cllr Harris explained that the material used had been left over from a previous contract and was not suitable for main highway use.

Cllr Kimberley reported continued dog fouling in the vicinity of the school. Although he had a suspect in mind he could not be completely sure but would keep a watching brief. Cllr Stuart recommended that all instances noted should be reported to George Lager (CDC) who will take action against those responsible if evidence is forthcoming.

Cllr Kimberley reported that he had confronted young bike riders who were using the area in the vicinity of the Millennium Seat in Bow Wow to practice their tricks and thereby disfiguring the bank. The youths had accepted the admonishment and thanked Cllr Kimberley for pointing out that there was a perfectly good alternative at the Upper Up humps and bumps.

Cllr Harris reported that some of the road signs at the end of Broadway Lane where it meets the Spine Road and the junction of Cerney Wick Lane were totally obscured with mud. There are a further two posts with no signs attached close by. The Clerk will inform Paul Swift at Gloucestershire Highways.

Cllr Harris was concerned at the silt build up in the vicinity of Fanshawe weir and the condition of the stock boards. The Clerk quoted from an email sent by Chris Savage (Environment Agency) on 17th October 2013: "Our operations team have recently inspected the gravel shoal build up around the Fanshawe Weir. They do not consider the shoal to represent a flood risk at this time but will keep monitoring the situation. The Fanshawe weir itself was last inspected in July this year. Whilst there are some defects to the sill the weir overall was rated as being in a fair condition. As the weir is in private ownership we do not plan to carry out any maintenance work on it. We will continue to inspect it as part of our asset inspection programme. Should the weir deteriorate further towards a poor condition we will request the owner carry out remedial repairs to return it to its required condition."

Damaged Street Sign at entrance to Box Bush road

Cllr Jay reported that one of the supporting posts of the Box Bush road street sign was badly corroded and asked the Clerk to report the damage to Cotswold District Council.

There being no further business Cllr Stuart had closed the meeting at 8.22pm.

Cllr Mrs Chapman asked the Clerk to enquire from the Yvonne Poole, Enforcement Officer at CDC if there was an update on the validity of advertisements in the vicinity of the crossroads at the end of Broadway Lane, Spine Road and Cerney Wick Lane.

Cllr Kimberley reported that the bench situated opposite Londis and the grassed area leading to Berkeley Close had been damaged. One of the slats of the seating had been broken and possibly the back rest needed attention also. The Clerk will ask Bob Berry to repair it.

Cllr Webb reported that the hedge of Yew Tree House, Sudeley Drive was over grown and the occupants should be requested to cut it back. The Clerk will write to the residents.

Cllr Harris reported that he had attended a meeting of the Water Park Trust on 26th November.

Cllr Jay reported that he had attended a meeting at Prospects Services on 12th November; on 20th November he had attended a meeting with British Legion members to discuss plans to commemorate the start of the First World War; on 26th November he had attended at Water Park Trust meeting. Cllr Jay thanked all those Parish Councillors who had responded positively that they would attend a GAPTC training event on employment scheduled for Wednesday 26th February from 7pm to 9pm.
